The engagement of outsourced manpower is intended solely to meet operational requirements of NDTL and shall not confer any claim for regular appointment, absorption or continuation beyond the terms of the contract. The selected agency shall remain the employer of the deployed personnel and shall be solely responsible for compliance with all applicable statutory obligations and other applicable regulations.
- f. The PBG will be refunded after 60 days from the expiry of the contract or after the expiry of the extended period of the contract, whichever is later.
- g. In the event of resignation or termination of any staff member, NDTL reserves the right to select and approve a suitable replacement candidate, in accordance with the requirements of the contract.
- h. NDTL reserves the right, on a case-to-case basis, to upgrade or downgrade the positions of the deployed staff, as may be required during the currency of the contract, provided that such changes are accommodated within the overall contract value.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. 11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
