2. Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 8. ## 4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Pro-Rata Rate Applicability: Ad-hoc daily hiring for Sedans/ Premium Sedans shall be payable on a pro-rata basis in respective cases as derived from the accepted monthly contract rates.
2. **Daily Hiring:** In the event of non-availability of a Premium Sedan at the time of requirement under the Daily Hiring arrangement, if the Service Provider provides an SUV vehicle in lieu thereof, the rates payable shall be restricted to the applicable rates for a Premium Sedan, as derived from the accepted monthly contract rates, with the calculation being made in accordance with the condition stipulated at **S. No. 01** above.
3. Proximity Condition: The registered local office of the Service Provider must be situated within a 5-kilometre radius of NDTL premises.
4. Distance Verification: Bidders must submit verifiable documentary proof (e.g., Google Maps mileage report) verifying the distance between their registered office and NDTL.
5. 24/7 Driver Availability: Drivers must be assigned on a 24/7 standby basis to respond to urgent official requirements upon short notice.

6. Odometer readings (kilometer charging) shall strictly commence and terminate at NDTL premises (NDTL-to-NDTL). Garage-to-garage kilometer calculation shall not be entertained.
7. Contract Extension Provision: The contract duration may be extended up to an additional 6 months or more beyond the initial 2-year period, subject to satisfactory service delivery and mutual consent according to need.
8. Cumulative Mileage Limit: Deployed vehicles Premium Sedan (Maruti Suzuki Ciaz, Honda City, and Hyundai Verna) and Sedan (Maruti Suzuki Dzire, Honda Amaze, and Tata Tigor) must be in pristine condition, with total odometer running not exceeding 10,000 km at the time of initial deployment.
9. PBG will be refunded after 60 days of expiring of contract or after expiring of extended period of contract, whichever is later.

## अस्वीकरण/Disclaimer

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document.
